
- 1. Bracket Code change from EI LIMITS to EI W/H Q for the second instance of the CALC CREDIT BASE W Method Step (12th Method Step on the list below)
- 2. Method Step CALC CREDIT BASE W inserted as step 14 to gather the QPIP premiums from the existing Payroll Journal (if not over limit defined in the QPIP EE Bracket Code)
- 3. Method Step CREDIT % OF ADJUSTED inserted as step 15 in the calculation to apply the lowest Federal tax rate to the value gather by step 14

A new arrangement of method steps is required to incorporate the new 6% Reduction in Taxable Income for the purpose of Quebec Income Tax calculations.



Import Instructions (Step 1)

Using the Import Payroll Control Data periodic activity

- Save the import file (360_400CATaxDatX.txt or 360_400CATax&SampleDatX.txt) to a folder on your network or your local hard drive.
- 2. Open Navision to the Payroll Main Menu.
- 3. Select "Periodic Activities>>Import Payroll Control Data..."
- 4. Use the Ellipsis button at the end of the "File Name" field to browse to the import file. (*See Import Payroll Control Data Figure 5*)
- 5. Select the import file and click 'Open'.
- 6. Click "OK" on the Import Payroll Control Data form:

Import Payroll Control Data – Figure 5 (example only)

- 7. The "Pay Control Update Worksheet" will display which controls are included in the Import file. Review the default settings to insure each control is being handled in the desired manner. You can select to Create, Update, or Ignore each Payroll Control.
- 8. Placing a checkmark on the desired action can change the action for each Payroll Control Code Make changes if necessary. You should select "Ignore" for all controls that do not apply to you. (See Pay Control Update Worksheet Figure 6)

 NOTE: Subsidiary records used on the Payroll Control or Calc Method Line will be updated into the database regardless if they will be used or not.

 These include Payroll Calc Method and Payroll Calc Method Lines, Payroll Rates, Payroll Tax Types, Activations, and Split Information records.

The "Pay Control Tax Form Classes" checkbox will have to be checked in order to update/insert Pay Control Tax Form Class records on an existing Payroll Control.


a. Line Check Boxes:

- Create This action will create the Payroll Control Code specified on the line if it does not already exist in the database. Only the selected components will be created, according to the Control Check boxes based on the control check boxes settings (See below for details on Control Check boxes)
- ii. Update This action will update the existing settings of the Payroll Control Code, specified on the line, according to the selected Control Check boxes. (See below for details on Control Check boxes)
- iii. Ignore This action will not apply any changes to the database relating to the Payroll Control Code Specified on the line.

b. Control Check Boxes:


- i. Update the fields on the Payroll Control Card This option updates only the fields that are on the General and Calculations tab on the Payroll Control Card. It does not refer to any components of the Payroll Control that are accessed through either the Pay Control or Calculation menu buttons at the bottom of the Payroll Control Card.
- ii. Brackets This option will add/update bracket details for the Payroll Control Code specified on the line according to the effective date from the import file.
- iii. Base Amount This option will add/update base amount details for the Payroll Control Code specified on the line according to the effective date from the import file.
- iv. Pay Control Tax Form Classes This option will add/update Tax Form Classes for the Payroll Control Code specified on the line.
- v. Reporting Authorities This option will add/update the Reporting Authority information for the Payroll Control Code specified on the line.

- 9. Click 'X' to close the window to cancel the process
- 10. Click 'Process' to initiate the routine.
- 11. Review the import message for each Payroll Control Code to insure the desired action was performed. (See Pay Control Update Worksheet Figure 7)
